Law of Ukraine "On Access to Public Information" does not apply:

- on relations regarding the receipt of information by subjects of authority in the exercise of their functions;
- on relations in the field of citizens' appeals, which are regulated by a special law.

Public information with limited access:

- **confidential** information about an individual and legal entity that is provided with their consent, in the absence of consent only in the interests of national security, economic well-being, human rights;
- **service** information contained in documents of government entities or collected in the course of operational-search, counterintelligence activities, in the field of national defence;
- **secret** information that may harm an individual, society and the state (state, professional, banking, intelligence secrets, pre-trial investigation secrets, other secrets provided for by law).таємниця).

Information containing data from a pretrial investigation in a specific criminal proceeding shall be provided only with the written permission of the prosecutor in the scope determined by him and in the manner prescribed by the Criminal Procedure Code of Ukraine.

Information shall not be made public or provided upon request if this violates the requirements of the Law of Ukraine "On Personal Data Protection".

Public information

information reflected and documented by any means, on any media, that was received or created in the process of performing by a subject of government authority its duties, provided for by current legislation, or that is in its possession.

Public information is open access, except in cases established by law.

The request for information must contain:

- name (title) of the requester, postal address or e-mail communication number, if available:
- general description of the information or type, title, details or content of the document, that are requested (if known);
- ✓ signature and date if the request in written form.

Request processing times:

5 working days;

20 working days – if a large amount of information is requested or a search is required among a large amount of data;

48 hours – information is requested that is necessary to protect life and freedom of the individual, regarding the state of the environment, the quality of food products and household items, accidents, catastrophes, dangerous natural phenomena, and other extraordinary events that have occurred (may occur) and threaten the safety of citizens. The request for urgent processing of the request must be substantiated.

Fee for information providing:

- √ information for request is free;
- the requester is obliged to reimburse the actual costs of copying and printing if the fulfilment of the request involves making copies of documents exceeding 10 page;
- personal information and information of public interest are provided free of charge.
